

MUNICIPALITY OF CROWSNEST PASS
BY-LAW NO. 818, 2011

The Utility Rate By-Law

A By-law of the Municipality of the Crowsnest Pass, in the Province of Alberta, to identify tariffs, service charges, deposits, penalties and fines for the Municipal Water System, the Municipal Sewer system, the Municipal Solid Waste Program and the Municipal Recycling Program.

WHEREAS Section 7 (g) of the Municipal Government Act, Chapter M-26, Revised Statutes of Alberta 2000 and any amendments thereto, Council may pass By-Laws charging service charges to all persons who use, receive and/or require utility service connections to the Sewerage and Water systems and access to the Municipal Garbage and Recycling Programs of the Municipality of Crowsnest Pass. The service charges, deposits, penalties and fines are to be determined by the Council in such a manner, as it considers equitable, having regard to the Municipality's costs for each utility services it provides.

AND WHEREAS it is deemed just and proper to levy a service charge on all persons who use, receive and/or require utility services and connections thereto to assist the Municipality with the cost of providing such services.

The Council of the Municipality of Crowsnest Pass, in the Province of Alberta, duly assembled, hereby enacts as follows:

1. This By-Law may be cited as **The Utility Rate By-Law**. Where the terms of this By-Law conflict with the provisions of any other By-Law of the Municipality of Crowsnest Pass, this By-Law shall prevail.
2. Tariffs, service charges, deposits, penalties and fines for water, sewer, garbage and recycling contained in the attached "Schedule A" are to be charged to all persons who use, receive and/or require utility service connections to the Sewerage and Water systems and access to the Municipal Garbage and Recycling Programs of the Municipality of Crowsnest Pass. Utility services are charged as a package.
3. **EFFECTIVE DATE**

Bylaw No.818, 2011 takes effect January 1, 2011.

That By Law No. 788, 2010 be repealed.

That By Law No. 622, 2004, By Law No. 670, 2006, By Law No. 728, 2007, By Law No. 729, 2007, By Law No. 779, 2009, be amended to include By Law No. 818, 2011 Schedule A.

Read a first time this 15th day of February 2011.

Read a second time this 15th day of February 2011.

Read a third and final time, this 15th day of February 2011.
